To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina situate lying and being in Greenville Township known and designated as Lot 10, Section A, of Woodville heights according to plat of W.J. Riddle, recorded in Plat Book L at pages 14 and 15 and described as follows: BEGINNING at an iron pin at the southwestern intersection of Spruce Street and Oak Street and running thence with the west side of Spruce Street S. 9-50 W. 166.4 Feet to corner of Lot 1; thence along rear line of Lot 1 S. 73-10 W., 75.8 Feet to rear corner of Lot 11, thence along common line of lots 10 and 11 W. 9-00 W. 150 Feet to pin on west side of Oak Street; thence along Oak Street N 73-10 E 129.8 feet to the point of beginning. This property is conveyed subject to restrictive covenants of record and to any easements or rights of way affecting same.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
