"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, and being shown and designated as Lots 7 and 8 on plat of property entitled "Property of W. T. Looper" prepared by W. J. Riddle, Surveyor, which plat is recorded in the RMC Office for Greenville County in Plat Book BB at Page 6 and having, according to said plat, metes and bounds as shown thereon.
