SEND GREETINGS:

We the said Marion C. Parham, Jr. and Hazel D. Parham

hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Greenville, S.
