SEND GREETING:

WHEREAS, we the said James Harold Huey and Dorothy P. Huey in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Forty Thousand and No/100-----(\$ 40,000.00 ) Dollars, with interest from the date hereof at the rate of 16three per cent (163/4%) per annum, unpaid interest to forths bear interest at the same rate, to be repaid in installments of Six Hundred Eight and 53/100-----
