AND IT IS AGREED by and between the parties that in case of forecksure of this mortgage, by suit or otherwise, the Mortgagee shall recover of the e sum as attorney's fee, not to exceed 15% of the unpaid debt after default and referral to an attorney not a salaried employee of Mortgagee, which shall be secured by this mortgage, and shall be included in judgment of foreclosure


