MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, R. D. OWENS and POLLY DIANE OWENS

(hereinafter referred to as Mortgagor) is well and truly indebted unto FRANK RICHARD WASHICK

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of SEVENTEEN THOUSAND NINE HUNDRED and NO/100-----

-----Dollars (\$ 17,900.00) due and payable

in 240 equal installments of Two Hundred Twenty-two & 59/100 Dollars beginning October 1, 1981

with interest thereon from date at the rate of fourteen per centum per annum, to be paid: monthly (14%)

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as One (1) acre, more or less, on a plat entitled "Map Showing Lot of Fred C. King as Purchased from Mrs. Ruth S. King", prepared by B.R.T. Todd, Surveyor, dated August 16, 1952, and being more particularly described in accordance with said plat, to-wit:

BEGINNING at a point in the center of Dunklin Bridge Road, said point being the joint corner with property now or formerly of Mrs. Ruth S. King and running thence along the center of Dunklin Bridge Road, S. 63-E. 209 feet to a point in the center of said road; thence along the joint property line now or formerly of Mrs. Ruth S. King, S. 27 W. 209 feet to a point; thence continuing along the joint property line now or formerly of Mrs. Ruth S. King N. 63 W. 209 feet to a point; thence continuing along the joint property line now or formerly of Mrs. Ruth S. King N. 27 E. 209 feet to the point of beginning.
