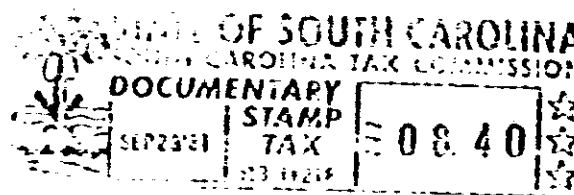

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Maycourt Street and being shown and designated as Lots 25 and 26 of Block F on Plat of Buena Vista Subdivision as recorded in the RMC Office for Greenville County, South Carolina in Plat Book W, Page 29, and having the metes and bounds as shown thereon.
