

Whereas, I, we the saidCharles L. and Linda B. Upton,
hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith,
stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina,
Greenville , S. C., hereinafter called Mortgagee, the sum of \$3214.13
plus interest as stated in the note or obligation, being due and payable in equal
monthly installments commencing on the $31st$ day of $0ctober$, 1981 , and on the
same date of each successive month thereafter.
Said note provides that past due principal and/or interest shall bear interest at the rate of seven (7%) per cent per annum as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee or holder hereof. All that lot of land in the county of Greenville, state of South Carolina, being a southern portion of Lot No. 9 on plat of Staunton Court, recorded in the RMC Office for Greenville County in Plat Book PPP at Page 143, and having according to said plat and a recent survey mady by Jones Engineering Service March 24, 1975 the following metes and bounds, courses and distances to=wit:
Beginning at an iron pin on the southern edge of the turn-around of Staunton Court, the tangent joint corner of Lots Nos. 9 & 10; thence S. 23-45 W. 174.5 feet to an iron pin; thence N. 32-04 W. 132 feet to an iron pin in the rear line of said lot No. 9; thence with a new line through said lot N. 47-27 E. 69.8 feet to an iron pin in the turn-around of Staunton Court; thence with the curve of said turn-around, the chord of which is S. 89-34 E. 90 feet to the beginning corner.
This is the same property conveyed to Charles T. Upton and Linda B. Upton by virtue of a deed from H.C. Bond, Jr. dated May 9, 1975 and recorded in the RMC Office for Greenville County in Deed Book 1016 at Page 552 on May 9, 1975.
