WHEREAS, we, John W. Cantrell and Jerldean S. Cantrell,

(hereinafter referred to as Mortgagor) is well and truly indebted unto Joe Williams

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand and No/100 -----

in five (5) annual installments of One Thousand Four Hundred and No/100 (\$1,400.00) Dollars plus interest commencing October 15th, 1982,

with interest thereon from date at the rate of 12% per centum per annum, to be paid: at time of each installment

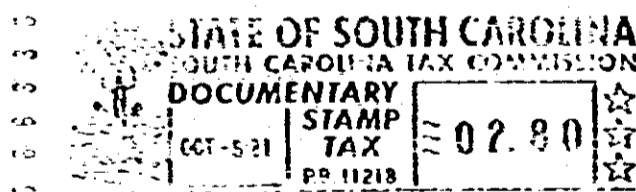
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 2.5 acres more or less as shown on plat of property of W. B. Allen Estate and William C. Allen according to a survey made by C. O. Riddle as revised on 9/10/68 and having according to said survey the following approximate courses and distances:

BEGINNING at a nail and cap in the center of a country road and running thence along the approximate center of said road N. 79-50 E. 320.3 feet; running thence with the road the approximate courses and distances: S. 13-22 E. 110.1 feet and S. 37-15 E. 129 feet to a cone bridge; running thence with the creek as the line approximately 521.4 feet; running thence N. 6-05 W. 244.1 feet more or less to the center of a road, the beginning corner.

This is the same property conveyed to John W. Cantrell and Jerldean S. Cantrell, by deed dated September 29, 1981, of Joe Williams which is being recorded simultaneously herewith in the RMC Office for Greenville County, South Carolina, in Deed Book 1156, at Page 203.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
