

- 20. Release. Upon payment of all sums secured by this Mortgage, this Mortgage shall become null and void. Lender shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of recordation, if any.
- 21. Waiver of Homestead. Borrower hereby waives all rights of homestead exemption in the Property.
