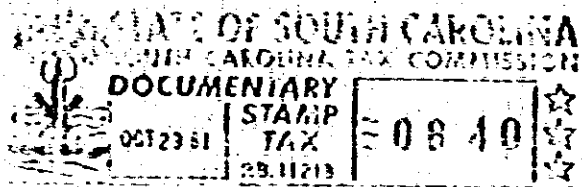
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the northwestern side of Manley Drive, being known and designated as Lot No. 6 of Paris Mountain Heights, as shown on plat thereof made by J. C. Hill, Surveyor, dated September 13, 1954, and recorded in the RMC Office for Greenville County, and being further shown on a more recent plat by Freeland & Associates, dated October 20, 1980, entitled "Survey for Lindsey D. Cole, III", recorded in the RMC Office for Greenville County in Plat Book 8-H at Page 7, and having, according to said latter plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Manley Drive, joint front corner of Lots Nos. 5 and 6, and running thence along the common line of said lots, N. 43-20 W. 195.2 feet to an iron pin in the center of Manley Drive; thence along the center line of said drive, N. 56-38 E. 88.8 feet to an iron pin, joint rear corner of Lots Nos. 6 and 7; thence along the common line of said lots, S. 47-00 E. 186.4 feet to an iron pin in the center of Manley Drive; thence along the center of said drive, S. 50-16 W. 99.5 feet to an iron pin, the point of beginning.
