WHEREAS, the Mortgagor is well and truly indebted unto ASSOCIATES FINANCIAL SERVICES CO INC

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Sixty two thousand five hundred twenty and no/100-----DOLLARS (\$ 62,520.00 ),  
with interest thereon from date at the rate of \_\_\_\_\_ per centum per annum, said principal and interest to be repaid:

in 120 monthly installments of \$521.00 each, the first of which shall be due and payable on 12-9-81, and a like installment due on the same day of each month thereafter until paid in full; said payments including interest at eh rate of 18% per annum.

AMOUNT ADVANCED: 28,914.70.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 11.9 acres, more or less according to plat prepared by American Surveying & Mapping dated August 15, 1968, recorded in Deed Book 908 at Page 481 of the RMC Office for Greenville County, having metes and bounds as follows:

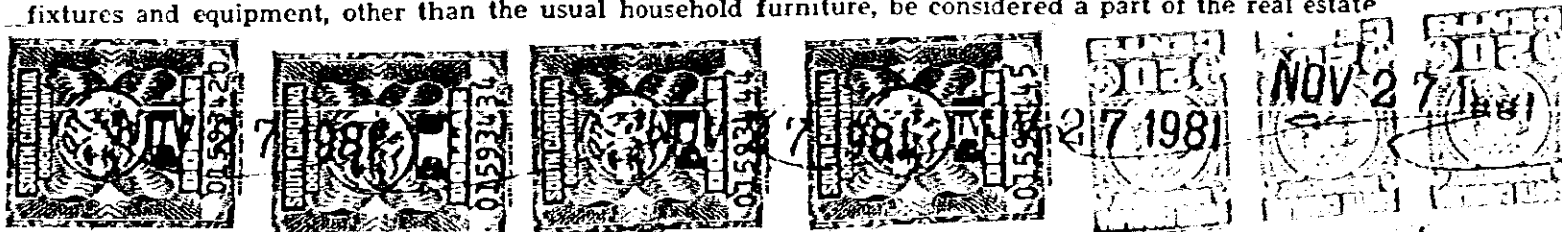
BEGINNING at an iron pin on the northeastern side of Virginia Road at the joint fornt corner of the property of W.B. McCarter and running thence with the line of McCarter, N 46-51 E 1,158 feet to an iron pin on the southwestern side of a branch; thence with the branch as the line in a southeasterly direction 672 feet to an iron pin in or near said branch on line of property of Langley; thence with Langley line, S54-42 W 815.4 feet to an iron pin; thence along line of Simpson, N 57-39 W 352.4 feet to an iron pin; thence, S 80-22 W 340.2 feet to an iron pin on the northeastern side of Virginia Road; thence along said Road, N 10-10 E 34 feet to the point of beginning.
