ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southern side of Painter Road and being known and designated as that certain 1.28 acre tract as shown on a plat entitled "property of Sarah M. Hindman," made by C.O. Riddle, which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 5% at page 79 and having, according to said plat, the following metes and bounds, to-wit:
