All that piece, parcel or lot of land with building and improvements thereon, situate, lying and being in Greenville County, South Carolina, and being shown as Lot 68, Section 3, on a plat of a subdivision for Victor Monaghan Mills recorded in the P.M.C. Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

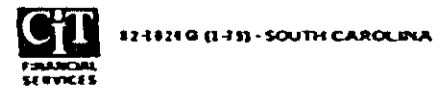
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
