TO ALL WHOM THESE PRESENTS MAY CONCERN:

SEND GREETINGS:

Whereas, I, we the said Charles P. Brown and Helen L. Brown, hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Greenville, S. C., hereinafter called Mortgagee, the sum of \$11,110.48 plus interest as stated in the note or obligation, being due and payable in 120 equal monthly installments commencing on the last day of March, 1982, and on the same date of each successive month thereafter.

Said note provides that past due principal and/or interest shall bear interest at the rate of seven (7%) per cent per annum as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee or holder hereof. Forbearance to exercise this right with respect to any failure or breach of the maker shall not constitute a waiver of the right as to any subsequent failure or breach. All that piece, parcel or lot of land in Chick Springs Township, County of Greenville, State of SC, lying and being situate on the Northerly side of Range Road, being the Southern Portion of a 2.65 acre tract according to Plat of Property of Lily McC. Loftis, prepared by Terry T. Dill, Reg. C.E. & L.S., dated 2-9-68, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Range Road, said point being 480 ft. W. of St. Mark Road, and running thence N. 22-00 W. 220 ft. to a point; thence on a straight line across the center of the said 2.65 acre tract, S. 65-00 W. 264 ft. more or less, to a point; thence S 22-00 E. 220 ft. to an iron pin on the Northerly side of Range Road; thence along said Range Road N. 65-00 E. 263 ft. to an iron pin at the point of beginning and being a portion of Lot 1, Block 1, at Page T. 24 of the Greenville County Block Book in School District 265.
