with interest thereon from date at the rate of 17 per centum per annum, to be paid: monthly.

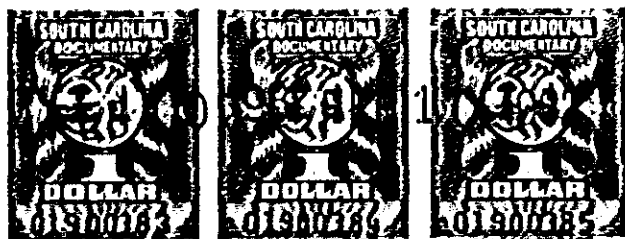

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Honeysuckle Drive and being shown and designated as a 2.0 acre tract on plat entitled "Property of Mary Moore Thompson", prepared by Jones Engineering Service, dated January 25, 1982, and recorded in the RMC Office for Greenville County in Plat Book 2X at Page 81, and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
