

TIDWELL, recorded in the RMC Office for Greenville County, S. C., in Plat Book BB, page 32, and also being shown as PROPERTY OF TOM E. JEFFERSON, on plat made by R. B. Bruce, recorded in the RMC Office for Greenville County, S. C., in Plat Book 4-Q, page 130, reference to which is hereby craved for the metes and bounds thereof.

The within mortgage is secondary and junior in lien to a first mortgage given to Thomas & Hill, Inc., (now The Kissell Company) recorded June 21, 1972 in Mortgage Book 1238, page 101, in the original sum of \$17,950.00, and is junior in lien to a second mortgage given to United Virginia Mortgage Corporation, of even date, in the original sum of \$8,650.00.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenant that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
