Notwithstanding anything to the contrary contained in this paragraph, it is expressly understood and agreed that Mortgagor shall have the right without obtaining the prior approval of Mortgagee to enter into any Lease, provided that such Lease (i) is on a lease form approved by Mortgagee and (ii) complies with minimum rent and tax and utility escalation requirements approved by Mortgagee.
