To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Rafford Lane, being known and designated as as Lot 6 of a subdivision entitled "Addition to North Meadow Heights" as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book 11 at Page 23 and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at an Iron pin on the northern side of Tafford Lane, joint front corner of Lots Nos. 6 and 7 and running thence with the joint line of said lots, N 22-45 E. 165 feet to an Iron pin; thence N 67-15 W. 112.2 feet to an Iron pin on the eastern side of Meadow Crest Circle; thence with Meadow Crest Circle S 10-14 W 144 feet to an Iron pin; thence continuing with Meadow Crest Circle, as it intersects with Rafford Lane, following the curvature thereof, the chord of which is S 26-19 E. 37.8 feet to an Iron pin on the northern side of Rafford Lane; thence with Rafford Lane, S 67-15 E. 50 feet to the beginning corner.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
