

18. BORROWER'S MAINTENANCE OF PROPERTY

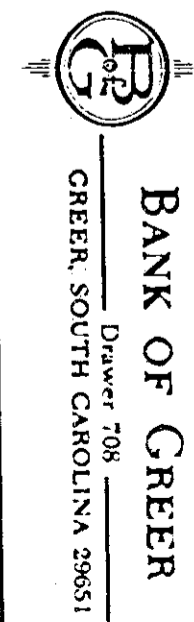
