

SCHEDULE 1.

(Continuation of Property Description on Mortgage)

ALSO: ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the Northern side of Hall Road near the City of Greenville, being designated as the lot of F. A. Capps on plat of property of Timms, Bryant, Capps, Langley, et al, on Hall Road, made by C.C. Jones in November, 1956, recorded in Plat Book KK at page 83, described as follows:

BEGINNING at a stake on the North side of Hall Road at a corner of property designated as the lot of Lola Timms and running thence with the line of said property, N. 46-11 E. 207.7 feet to a stake; thence N. 58-58W. 136.8 feet to a stake near a branch; thence with the branch as the line, the traverse of which is S. 33-37 W. 200.7 feet to a point in the center of Hall Road; thence with said road S. 60-40 E. 88.2 feet to the beginning corner.

ALSO: ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and according to a Plat by J. L. Montgomery, III, R.L.S., dated May, 1973, having the following metes and bounds, to-wit:

BEGINNING at an iron pin 93.9 feet from Hall Road N. 51-30 E. 112.8 feet to an iron pin; thence N. 58-18 W. 101.2 feet to an iron pin; thence S. 47-25 W. 92 feet to an iron pin; thence S. 47-06 E. 89.4 feet to the point of beginning.

ALSO: ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina on the northwestern side of Paris Mountain Road and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Paris Mountain Road and running thence N. 39-30 W. 91.5 feet to an iron pin; thence S. 45-13 W. 31.7 feet to an iron pin; thence N. 59-08 W. 61.2 feet to an iron pin; thence with the rear line of said lot, N. 51-30 E. 117.9 feet to an iron pin; thence S. 58-58 E. 36.4 feet to an iron pin; thence S. 40-45 E. 110 feet to a point on the northwestern side of Paris Mountain Road; thence with said road S. 52-30 W. 66 feet to the point of beginning.

ALSO: ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina situate on the northern side of Hall Road, near the Paris Mountain Road, having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwestern corner of lot conveyed to F.A. Capps by Martha R. Bryant, and running thence N. 52-00 E. 90.42 feet to a stake at the northwest corner of said property; thence S. 59-3/4 E. 75 feet to a stake; thence S. 52-00 W. 90.42 feet, more or less, to a stake on Hall Road; thence with the northern side of said road, N. 59-3/4 W. 75 feet to the point of beginning.

ALSO: ALL three parcels or lots of land in Chick Springs Township, Greenville County, State of South Carolina, situate on the western side of Paris Mountain Road and described as follows:

BEGINNING at a stake on the northwestern side of Paris Mountain Road and running thence N. 52-00 E. 90.42 feet to a stake; thence N. 59-3/4 W. 80 feet to a stake; thence S. 52-00 E. 90.42 feet to a stake on Hall Road; thence S. 59-3/4 E. 80 feet to the point of beginning.

BEGINNING at the corner of lot above mentioned and running thence in a westerly direction 91 feet to an iron pin; thence N. 31-07 feet to an iron pin; thence N. 31-07 feet to an iron pin; thence in an easterly direction 91.5 feet to the beginning corner and being triangular in shape.
