THIS MORTGAGE is made this 30th day of April,  
1982, between the Mortgagor, HERITAGE HOMES, INC.,

contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by  
Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage,  
grant and convey to Lender and Lender's successors and assigns the following described property located
