(Amount advanced being \$14,987.27)

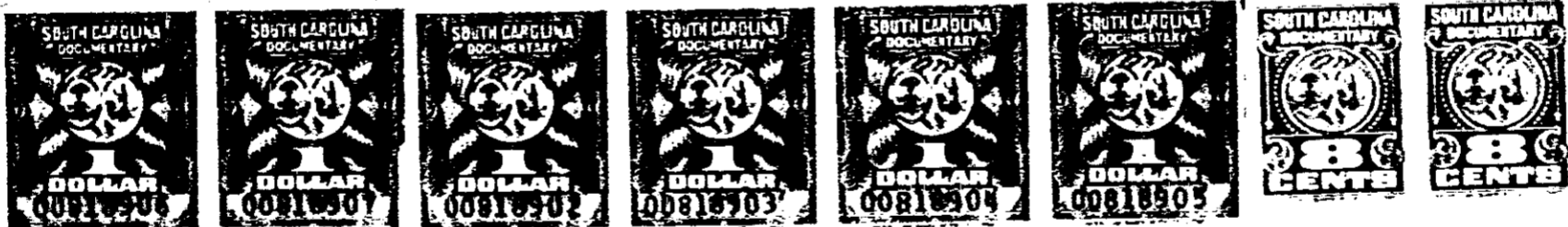
with interest thereon from at the rate of 18.0% APR per centum per annum, to be paid:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Amberwood Lane and being shown and designated as Lot No. 38 of Adams Mill Estates Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-R at Page 31 and having, according to said plat, such metes and bounds as are more fully shown thereon.
