with interest thereon from date at the rate of 13.00 per centum per annum, to be paid: monthly

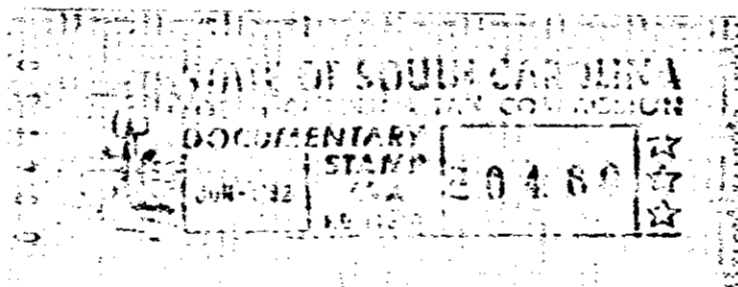
