ALL that certain piece, parcel or tract of land with the improvements thereon located and being situate in the State of South Carolina, County of Greenville, shown as containing 29.69 acres, more or less, and being described according to a compiled plat by John C. Smith & Son, Reg. L. S. No. 1443 & 7882 representing property owned by John D. Huff, as said plat being of received the RMC office for Greenville County South Carolina in Plat Book 9.8 at Page 97 and having the courses and distances and metes and bounds as upon said plat appear which are hereby incorporated by reference as though fully set out herein and being more fully described as follows:
