MORTGAGE OF REAL ESTATE

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE in Bates Township on the southern side of Pleasant Retreat Road and being shown on a survey prepared for George S. Engle, III. and Janice H. Engle by W. R. Williams, Jr. dated May 24, 1982, to be recorded herewith, and containing 6.40 acres, more or less, reference being had to said survey for a more complete metes and bounds description.

The above described property is the same acquired by the mortgagors by deed from the mortgagees dated June 14, 1982 to be recorded herewith.

It is agreed that the obligations secured hereby will not be called due on a subsequent sale of the real estate for which this note is being given as partial payment but that upon any such transfer the note holders may escalate the interest rate herein to 15%.
