IN CONSIDERATION of the sum of Three Dollars (\$3.00) paid to Mortgagor by Mortgagee and in order to secure the payment of a promissory note including any renewal, extension or modification thereof (hereinafter referred to as the "Note"), dated ...July 12, 1982....., to Mortgagee for the principal amount of Forty Thousand and No/100 (\$40,000.00)..... Dollars, plus interest thereon and costs of collection, including attorneys' fees, and to further secure all future advances or re-advances that may subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid Note or any renewal, extension or modification thereof or evidenced by any instrument given in substitution for said Note, Mortgagor has granted, bargained, sold and released to Mortgagee and the successors and assigns of Mortgagee, and by this Mortgage does grant, bargain, sell, and release to Mortgagee and the successors and assigns of Mortgagee, all the following real property (hereinafter referred to as the "Property"):

ALL that piece, parcel or lot of land situate, lying and being on the southern side of Little Texas Road near Travelers Rest, in the County of Greenville, State of South Carolina, and shown as a 10.09 acre tract on a survey prepared for James E. Haller and Mary M. Haller and, according to said plat, has the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Little Texas Road at the joint front corner of property of Haythorn and this tract, and running thence with the Haythorn property S. 25-30 E. 1,093.4 feet to an iron pin in the line of property of the City of Greenville; running thence with that property N. 75-55 W. 831.2 feet to a concrete monument in the line of property now or formerly of Batson; running thence with the Batson tract N. 7-23 E. 791.8 feet to a spike in the center of Little Texas Road; running thence with the center line of said road S. 81-25 E. 125 feet; thence continuing N. 85-50 E. 100 feet; thence continuing N. 44-41 E. 15 feet to an iron pin, point of beginning.
