"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Fountain Inn, being known and designated as Lot #33 on a plat entitled "LAKEVIEW TERRACE, Section 2" prepared by C.O. Riddle, RLS, dated February, 1966, and having the following metes and bounds, to-wit:
