(hereinafter referred to as Mortgagor) is well and truly indebted unto GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

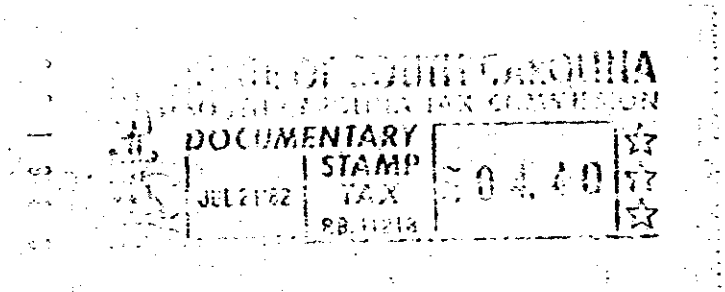

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 452, Section 2, as shown on a plat entitled "Subdivision for Abney Mills, Brandon Plant, Greenville, S.C.", made by Dalton & Neves, Engineers, Greenville, S.C., February, 1959, recorded in the R.M.C. Office for Greenville County in Plat Book QQ at page 56, described lot also being known as 20 Jones Street and fronting thereon 67 feet.
