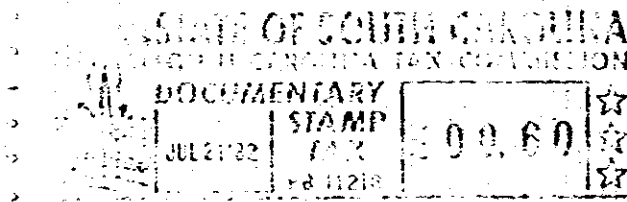
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, known and designated as Lot 3 of Block B in Subdivision of Sterling Annex located just beyond the limits of Greenville, as shown on plat recorded in Plat Book E, at page 141, in the RMC Office for Greenville County, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northside of Middleton Street, a distance of 155 feet from the northwest corner of Maloy and Middleton Streets and running thence along Middleton Street, N. 23-30 W. 50 feet to an iron pin; thence along the line of Lot 4, N. 69 E. 160 1/2 feet to an iron pin; thence S. 23-30 E. 50 feet to an iron pin; thence S. 69 W. 160 1/2 feet to the beginning.
