All that certain piece, parcel or tract of land on the Northwest side of Fmily Drive (formerly known as Moonville Road, In Grove Township, Greenville County, South Carolina, near Piedmont, S.C., containing ONE (1) ACRE according to a survey made by John C. Smith dated October 10,1975 and having, according to said survey, the following metes and bounds:

BEGINNING at a nail and cap in Emily Drive and running thence N. 65-45 W. 375 feet along line now or formerly of Mitchell; running thence along McGaha line 37-06 F. 125 feet to an iron pin; running thence along McGaha line S. 65-45 E. 375 feet to a nail and cap in Emily Drive; running along and through Emily Drive S. 37-06 W. 125 feet to the point of beginning.
