NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that lot of land in Greenville County, South Carolina, on the eastern side of Charlbury Street in the City of Greenville, being shown as Lot No. 25 on plat of Section F of Gower Estates recorded in the RMC Office for Greenville County in Plat Book JJJ at Page 99, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Charburly Street at the joint front corner of Lots 24 and 25, and running thence along the line of Lot 24, N. 70-04 E. 180.1 feet to an iron pin; thence N. 19-50 115 feet to an iron pin; thence with line of Lot 26, S. 70-04 W. 180.3 feet to an iron pin on the eastern side of Charlbury Street; thence along Charlbury Street, S. 19-56 E. 115 feet to the point of beginning.

This being the same property conveyed to the mortgagor by deed of Dennis P. Drozdak and Jean H. Drozdak of even date to be recorded herewith.

Mortgagors further agree that should fixed-rate conventional mortgage funds become available at an interest rate of twelve (12) per-cent prior to the completion of the term of this purchase money mortgage, mortgagors will within 60 days apply for new financing and retire the balance of the purchase money mortgage in full.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or bereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgages, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided berein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest (at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
