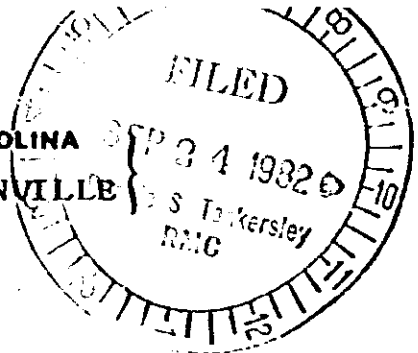

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, we, the said Richard Canada, Jr., and Frances E. Canada  
(hereinafter referred to as Mortgagor) is well and truly indebted unto Pickensville Finance Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight thousand nine hundred ninety-nine and 52/100-- Dollars (\$8999.52---) due and payable

in 48 successive monthly payments of Onehundred eighty-seven and 49/100 (\$187.49) Dollars beginning October 15, 1982 and due One hundred eighty-seven and 49/100 (\$187.49) Dollars each and every 15th. thereafter until the entire amount is paid in full.

with interest thereon from date at the rate of 18 per centum per annum, to be paid: semi-annually

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that piece, parcel or lot of land in Greenville County, South Carolina and being in the City of Greenville, on the Southwestern side of Sitka Avenue and being known and designated as Lot Number 20 on plat of Park View in the RMC Office of Greenville County, South Carolina, Plat Book M. at page 49; according to said plat, the property is more fully described as follows:

BEGINNING at an iron pin on the southwestern side of Sitka Avenue at the front joint corner of Lots 19 and 20 and running thence along said avenue N. 26-15 W. 50 feet to iron pin; thence along the joint line of lots 20 and 21 S. 63-45 W. 150 feet to iron pin on the northeastern side of Nicholtown Road; thence with said road S. 26-15 E. 50 feet to an iron pin; thence with the joint line of lots 19 and 20 N. 63-45 E. 150 feet to point of BEGINNING."
