WHEREAS, Mortgagor is indebted to Mortgagee in the principal sum of Nineteen Million Seven Hundred Thousand and No/100 Dollars (\$19,700,000.00) together with interest thereon, as evidenced by that certain promissory note of even date herewith, executed by Mortgagor and U. S. Shelter, a Massachusetts business trust ("Shelter"), and delivered to Mortgagee (the "Note") which by reference is made a part hereof to the same extent as though set out in full herein;
