ALSO, to Hollie R. Saxon and Barbara H. Saxon, their heirs and assigns forever, a right of way for ingress and egress across other lands of the grantors herein from South Carolina Highway S-23-69 to the above described 3.81 acre parcel of land. Said right of way being located and shown on the aforesaid Clinkscales plat along other lands of Phillips and being 20 feet in width as shown on said plat.

TO HAVE AND TO HOLD the above described property unto Mortgagee, his heirs, successors, and assigns forever.



In case of loss, Mortgagee is hereby authorized to adjust and sente any claim under any such policy and Mortgagee is authorized to collect and receipt for any such insurance money and to apply the same, at Mortgagee's option, in reduction of the ininsurance money, or any part thereof, in repairing the damage or restoring the improvedebtedness hereby secured, whether due or not, or to allow Me ments or other property without affecting the lien hereof for the full amount secured hereby.
