NOW, KNOW ALL MEN BY THESE PRESENTS: That the mortgagor, for and in consideration of the debt or sum of money aforesaid, and to better secure its payment to the mortgagee according to the condition of the note, and also in consideration of the further sum of THREE (\$3.00) DOLLARS to the mortgagor in hand well and truly paid by the mortgagee at and before the sealing and delivery of these presents, the receipt of which is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the mortgagee, its/his successors, heirs and assigns, the real property described as follows:

Tony Lee Holcombe and Rita G. Holcombe, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, Being known and designated as Lot No. 27, Belight Seights Subdivision, as shown on a plat recorded in Plat Book GG at Page 54 in the R.M.C. Office for Greenville County and having, according to said plat and also according to a more recent plat entitled "Plat for Tony Lee Holcombe and Rita C. Moldcabe" prepared by Mebb Surveying & Mapping Co., dated August 20, 1977, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Conley Street at the joint front corner of Lots 26 and 27 and running thence along said Conley Street N. 31-15 W. 100 feet to an iron pin at the joint front corners of Lots Nos. 27 and 28; thence with the line of Lot No. 28 N. 59-45 D. 150 feet to an iron pin; thence 3. 88-42 I. 91.7 feet to an iron pin; thence S. 23-00 I. 50 feet to an iron pin at the joint rear corner of Lots Nos. 27 and 26; thence with the line of Lot No. 26 S. 59-45 W. 220 feat to the point of beginning.

The within conveyance is subject to such restrictions, setback lines, zoning ordinances, utility easements and rights of way, if any, as may affect the above described property.

This is the identical property conveyed to the grantors herein by deed of Norman R. Jordan, Jr. and leborah T. Jordan dated Hay 27, 1976 and recorded in the R.M.C. Office for Greenville County, South Carolina in Beed Rook 1037 at Page 25 on Hay 27, 1976.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the premises belonging. or in anywise appertaining.

TO HAVE AND TO HOLD, all and singular the premises unto the mortgagee, its/his successors, heirs and assigns forever.

AND the mortgagor does hereby bind himself and his heirs and successors to warrant and forever defend all and singular the premises unto the mortgagee, its/his successors, heirs and assigns, from and against himself and his heirs and successors, lawfully claiming, or to claim the same, or any part thereof.

AND IT IS AGREED, by and between the parties that the mortgagor, his heirs and successors and assigns, shall keep any building erected on the premises insured against loss and damage by fire for the benefit of the mortgagee, for an amount not less than the sum shown above, with such company as shall be approved by the mortgagee, its/his successors, heirs and assigns, and shall deliver the policy to the mortgagee; and in default thereof, the mortgagee, its/his successors, heirs or assigns may effect such insurance and reimburse themselves under this mortgage for the expense thereof, together with interest thereon at the rate provided in the note from the date of its payment. And it is further agreed, in the event of other insurance and contribution between the insurers, that the mortgagee, its/his successors, heirs and assigns, shall be entitled to receive from the aggregate of the insurance monies to be paid a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the parties, that if the mortgagor, his heirs and successors or assigns, shall fail to pay all taxes and assessments upon the premise when they shall first become payable, then the mortgages, its/his successors, heirs or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and reimburse themselves under this mortgage for the sum so paid, with interest thereon at the rate provided in the note from the date of such payment.

AND IT IS AGREED, by and between the parties that upon any default for a period of more than ten days being made in the payment of the note or of the insurance premiums, or of the taxes, or of the assessments hereinebove mentioned, or failure to pay any other indebtedness which constitutes a lien upon the real property when the same shall severally become payable, then the entire unpaid amount of the debt (less any rebate of unearned Finance Charge) secured or intended to be secured hereby shall become due, at the option of the mortgagee, its/his successors, heirs or assigns, although the period for the payment thereof may not then have expired.
