All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, being known and designated as a portion of Lots Nos. 8,9 and 10, as shown on a plat of Property of T. T. Link, made by W.D. McBrayer, May 24, 1937, and recorded in the R.M.C. 
I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.


Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
