All that certain piece, parcel or unit, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Unit No. 14 of Rainbow Villas Horizontal Property Regime as is more fully described in the Master Deed dated June 4, 1982, and recorded in the Office of the RMC for Greenville County, S.
