"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Colonial Avenue, and being shown and designated as Lot Numbers 7, 8, and 9 in Block "AA" of Riverside Land Company according to a plat thereof recorded in Plat Book A, at page 323 (replated in Plat Book K, at Page 283) in the R.M.C. Office for Greenville County, South Carolina, with each lot having a frontage of 50 feet on Colonial Avenue and running 125 feet each back to an alley.
