All that piece, parcel or lot of land, with the building and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of Southe Carolina, being known and designated as Lot 69, Magnolia Acres, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book GG page 133, and having, according to said plat, the following metes and bounds to-wit:
