the Mortgagee at and before the sealing and delivery of this instrument, the receipt whereof is hereby acknowledged, have
granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mortgagee
Blazer Financial Services, Inc. of South Carolina -- the following described real property:

ALL that lot of land in the State of South Carolina, County of Greenville, being
known as Lot No. 101, on a plat of Hunters Acres, recorded in Plat Book "BB" at Page
51, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Southern side of Boyd Avenue, at the joint front corner
of Lots Nos. 100 and 101, and running thence with the line of Lot No. 100, S. 1-14
W. 204.4 feet; thence N. 89-56 W. 80 feet to the rear corner of Lot No. 102; thence
with the line of Lot No. 102, N. 1-14 E. 205.9 feet to a point on the Southern side
of Boyd Avenue; thence with the Southern side of Boyd Avenue, S. 88-46 E. 80 feet
to the point of beginning.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in

mortgaged premises, accruing and falling due from and after the service of a summons issued in an action to foreclose this
mortgage after default in the conditions thereof.

And It Is Agreed by and between the parties that in the case of foreclosure of this mortgage, by suit or otherwise, the Mortgagee
shall recover of the Mortgagor(s) a reasonable sum as attorney's fee, which shall be secured by this Mortgage, and shall be
included in judgment of foreclosure.
