### MORTGAGE

THIS MORTGAGE is made this 6th day of January, 1982, between the Mortgagor, Gerald R. Glur, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

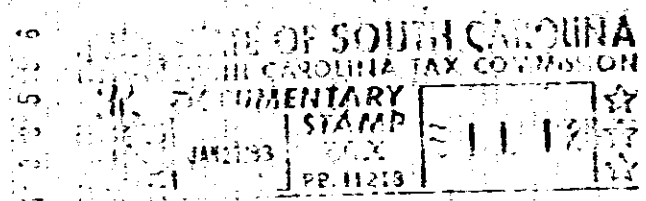
WHEREAS, Borrower is indebted to Lender in the principal sum of \$7,753.59 (Twenty-seven thousand seven hundred fifty-three and 59/100) Dollars, which indebtedness is evidenced by Borrower's note dated January 6, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on July 7, 1983.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

All that piece, parcel or lot of land, with all buildings and improvements, situate, lying and being on the northwestern side of Notchwood Court, in Greenville County, South Carolina, being shown and designated as Lot No. 26 on a plat of Parkdale Section II, made by C.O. Riddle, Surveyor, dated May 1965, recorded in the RMC Office for Greenville County, SC, in Plat Book BBB, Page 121, reference to which is hereby craved for the metes and bounds thereof.

This being the same property conveyed to the mortgagor by deed of Thomas L. Garner and Gloria Garner now known as Gloria Garner Clarke and recorded in the RMC Office for Greenville County on December 8, 1982 in Deed Book 1178 at page 587.

This is a second mortgage and is Junior in Lien to that mortgage executed by Gerald R. Glur to First Federal Savings and Loan Association which mortgage is recorded in the RMC Office for Greenville county on December 8, 1982 in Book 1588 at Page 327.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
