ALL that piece, parcel or lot of land, situate in the city of and county of Greenville, State of South Carolina, on the north side of Eisenhower Avenue (formerly Pearce Avenue) and being known and designated as Lot No. 1 on plat of Hutton Court recorded in the RMC Office for Greenville County in Plat Book NN at page 101 and having according to said plat such metes and bounds as said lot has by refrence there to.
