MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, GREGG R. ORTH AND JUDITH F. ORTH

(hereinafter referred to as Mortgagor) is well and truly indebted unto GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten thousand five hundred fifty-nine and 85/100----- Dollars (\$10,559.85) due and payable in 120 consecutive monthly installments of One hundred twenty-two and 71/100 (\$122.71) Dollars each, due and payable on the fifteenth day of each month, commencing February 15, 1983,

with interest thereon from said date at the rate of seven (7%) per centum per annum, to be paid: monthly.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greer, being shown and designated as the "Property of Maxwell B. Satterfield and Kathleen A. Satterfield" on plat prepared by Century Land Surveying Co., which plat is of record in the R.M.C. Office for Greenville County in Plat Book 6W-35, reference wo which is hereby craved for a metes and bounds description thereof.

DERIVATION: This being the same property conveyed to the Mortgagors herein by virtue of a deed from Maxwell B. Satterfield and Kathleen A. Satterfield recorded in the R.M.C. Office for Greenville County in Deed Book 1132 at Page 758 on September 8, 1980.
