C. in Mortgage Book 1536 at Page 716, does hereby release, relinquish and forever discharge from the lien of said mortgage (retaining its lien, however, on the balance of the property) the following described property:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 20 of a subdivision known as Schwiers at Cleveland according to a plat thereof prepared by Dalton & Neves Co. dated April, 1980 being recorded in the RMC Office for Greenville County in Plat Book 7-X at Page 20 and having according to a more recent plat prepared for College Properties, Inc. by Arbor Engineering dated February 17, 1983 and being recorded in the RMC Office for Greenville County in Plat Book 9-m at Page 18, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the intersection of Harvest Lane and Harvest Court and running thence with the southeastern side of Harvest Court N. 46-19 E. 65.06 feet to an iron pin at the corner of Lot 19 and running thence with the line of Lot 19 S. 49-17 E. 111.44 feet to an iron pin at the corner of Lot 21; running thence with the joint line of Lots 20 and 21 S. 40-51 W. 90.65 feet to an iron pin on the northeastern side of Harvest Lane; running thence with the northeastern side of Harvest Lane N. 47-49 W. 94.96 feet to an iron pin; thence with the intersection of Harvest Lane and Harvest Court N. 3-15 W. 32.61 feet to the point of beginning.
