THIS MORTGAGE is made this day of APRIL, 1983, between the Mortgagor, THE COFFEE STREET COMPANY, a South Carolina General Partnership (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of THE UNITED STATES OF AMERICA, whose address is 101 East Washington Street, Greenville, South Carolina (herein "Lender").

Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land, with all improvements thereon, situate, lying and being at the eastern corner of the intersection of East Coffee St. and North Brown Street in the City of Greenville, County of Greenville, State of South Carolina, being shown on plat of American Federal Savings and Loan Association, prepared by Freeland and Associates, dated June 29, 1981, recorded in Plat Book 8-R at page 87, and being described more particularly, according to said plat, to-wit:
