"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Gettysburg Street, and being the rear portion of Lots 1 & 2 of LINCOLN COURT as shown on plat recorded in plat book W page 90 of the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:
