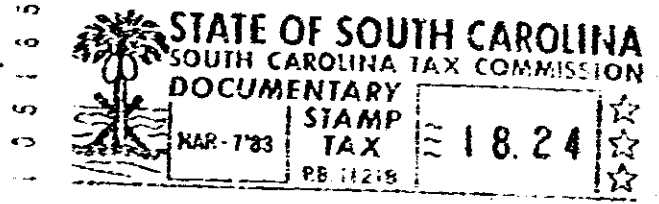
THIS MORTGAGE is made this 4th day of March, 19 83  
between the Mortgagor JAMES L. COWARD AND MARGARET R. COWARD  
(herein "Borrower"), and the Mortgagee, ALLIANCE MORTGAGE COMPANY,  
a corporation organized and existing under the laws of FLORIDA,  
whose address is 25 West Forsyth Street, P.O. Box 2259  
Jacksonville, Florida 32232 (herein "Lender").

South Carolina, County of Greenville on the western side of Cardinal Drive, between
