THIS MORTGAGE AND SECURITY AGREEMENT made this 12th , 19 83, between HUNTERS RIDGE, a day of Limited Partnership organized and existing under the laws of South Carolina ("Mortgagor"), whose address is c/o Paris Point Development, Inc., Box 2287, Greenville, South Carolina 29602 and CITY FEDERAL SAVINGS & LOAN ASSOCIATION, a Federal Savings and Loan Association ("Mortgagee"), whose address is 220 Centennial Avenue, Piscataway, New Jersey 08854,

## WITNESSETH:

WHEREAS, Mortgagor is indebted to Mortgagee in the principal sum of Three Million, One Hundred Ninety Thousand and No/100ths (\$3,190,000.00) Dollars together with interest thereon, as evidenced by that certain promissory note of even date herewith, executed by Mortgagor and delivered to Mortgagee, the final payment of which is due on or before , 1984, (the "Note") the 12th day of May which by reference is made a part hereof to the same extent as though set out in full herein;

NOW, THEREFORE, (a) to secure the performance and by Mortgagor of all covenants and conditions extension or in the Note, in any renewal, modification thereof, in this First Mortgage and Security Agreement and in all other instruments securing the Note; and (b) also to secure in accordance with Section 29-3-50, as amended, Code of Laws of South Carolina 1976: (i) all future advances and re-advances that may subsequently be made to Mortgagor by Mortgagee, evidenced by the aforesaid Note, or any other promissory notes, and all renewals and extensions thereof; provided, however, that nothing contained herein shall create an obligation on the part of Mortgagee to make future advances or re-advances to Mortgagor and (ii) all other indebtedness of Mortgagor to Mortgagee, now or hereafter existing, whether direct or indirect, the maximum amount of all indebtedness outstanding at any one time secured hereby not to exceed twice the face amount of the Note, plus interest thereon, all charges and expenses of collection incurred by Mortgagee, including court costs, and reasonable attorneys fees; and (c) also in order to charge the properties, interests and rights hereinafter described with such payment, performance and observance; and (d) for and in consideration of the sum of One and No/100 (\$1.00) Dollar paid by Mortgagee to Mortgagor this date, and for other valuable consideration, the receipt of which is acknowledged, Mortgagor does hereby grant, bargain, alien, remise, release, convey, assign, transfer, mortgage, hypothecate, pledge, deliver, set over, warrant and confirm unto Mortgagee, its successors and assigns forever all right, title and interest of Mortgagor in and to:
