NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released; and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land lying and being in O'Neal Township, Greenville County, State of South Carolina, having the following metes and bounds:

BEGINNING at a cedar stake on the west bank of a branch and running thence S 20-00 E. 327 ft. to a stake; thence S 41-45 E 183 feet to a stake in the road; thence N. 64-00 E. 453 feet to a stake on the Duncan line; thence with said line N. 5.05 W. 539 feet to an iron pin on bank of branch; thence down the branch S 83-45 W. 50 feet to bend; thence S 58-05 W 122 feet to a bend; thence S 54-45 W. 200 feet to a bend; thence S 69-45 W. 295.5 feet to the BEGINNING corner, containing 6.55 acres more or less.
